## **First Binational Conference on Migration, Human Mobility and Humanities**

April 10 to 12, 2024, virtual and free of charge

### **Call for Proposals**

#### **Conference Objective:**

The First Binational Conference on Migration, Human Mobility and Humanities seeks to foster the exchange of knowledge, experiences, and solutions in the field of migration, public policies, humanities, and education, with the aim of promoting inclusive, equitable, and quality education for migrants and contributing to their integration, protection of their human rights, and overall development in host societies. The I Binational Conference on Migration, Human Mobility, and Humanities welcomes proposals from students, professors, researchers, civil society organizations, and the general public.

## **Conference Themes:**

- Agenda 2030, universities and migrant persons.
- Migration, education, and cultural diversity environments in a border context.
- Public policies and good practices for migrants.
- Inclusion and protection of human rights for migrant persons.
- Ethics and migration.
- Human mobility and journalism.
- Humanistic responses to human displacement.

## **Participation Modalities:**

The Binational Conference Scientific Committee will select keynote speakers and round tables representing stakeholders in the field.

There are two additional participation modalities, subject to a double-blind review:

1. Papers.
2. Exchange of Experiences.
3. maximum of two proposals will be considered when submitted to [congreso.migracion@uach.mx](mailto:congreso.migracion@uach.mx).

### **1. Papers**

#### **Partial or final research reports**

Papers contributing to the field of migration and human mobility, with a focus on education, humanities, and/or public policies.

Requirements:

- Introduction: Explicitly addressing the research problem and its relationship with the state of knowledge in the thematic area, as well as objectives, questions, and hypotheses.
- Development: Arguing the theoretical and methodological approach that supports the research and discussing the results obtained.
- Conclusions: Presenting the study's findings in relation to its questions and objectives.
- APA References (7th Edition).

#### **Theoretical contributions**

- Papers discussing analytical categories that contribute to a better understanding of the field of migration and human mobility, focusing on education, humanities, and/or public policies.

Requirements:

- Introduction: Placing the theme, problem, or object of reflection in the context of the reviewed field's issues.
- Development: Presenting in an argumentative manner new categories or theoretical formulations, as well as the review or reconstruction of previous formulations.

- Conclusions: Presenting the findings of theoretical research in relation to its purposes and the field it belongs to. It should also include a reflection on the scientific and social relevance of the generated knowledge.
- APA References (7th edition).

### **Proposals format**

Proposals must follow this order:

#### Identification data

- 1.1. Area and thematic line.
- 1.2. Paper title.
- 1.3. Name of the author or authors (maximum three).
- 1.4. Affiliation institution and email address.
- 1.5. Summary, a maximum of 250 words.
- 1.6. Keywords: maximum of five.

#### Full Text

- 2.1. Maximum length: 4000 words, including bibliographic references, tables, and figures. Excluding title, abstract, and keywords. No footnotes are allowed.
- 2.2. Line spacing: 1 1/2, Garamond font, 12-point size.
- 2.3. Electronic file format: .doc or .docx
- 2.4. APA format (7th edition) references.

## **2. Exchange of Experiences**

A modality that creates a space for the exchange of best practices in the social, academic, business, and/or governmental sectors, oriented towards the study of migration and human mobility, with a focus on education, humanities, and/or public policies.

Proposals must follow this order:

#### Identification Data

- 1.1. Area and thematic line.
- 1.2. Title of the experience or intervention.
- 1.3. Name of the participants (maximum three).
- 1.4. Institution and email.
- 1.5. Summary of the intervention content, from 250 to 300 words.
- 1.6. Keywords: maximum of five.

#### Full Text

- 2.1. Maximum length: 4000 words, including bibliographic references, tables, and figures (optional), excluding title, abstract, and keywords. No footnotes are allowed.
- 2.2. 1.5 line spacing, Garamond font, 12-point size.
- 2.3. In .doc or .docx format.
- 2.3. The text may or may not have bibliographic references. If included, they must follow the APA format (7th Edition).

## **Review Process**

Proposals will be reviewed through a double-blind process, supervised by the BC Scientific Committee. This committee will notify the review of the results as scheduled.

Authors must consider the following:

If the proposal does not comply with the format requirements established in this call, it will not be reviewed.

Authors must adhere to the ethical standards established for scientific publications.

Decisions are final and cannot be appealed.

Once included in the program, modifications will not be considered.

## **IMPORTANT NOTE ON THE REVIEW PROCESS**

Complete articles submitted for publication will be assessed through a peer-review process. Authors will be notified of the committee's decision which may be: i) Accepted, ii) Accepted with modifications, or iii) Rejected. When accepted with modifications, authors must meet the requirements for publication established by their reviewers according to schedule.

The editorial committee will make final decisions about the publication of articles; submission does not guarantee publication.

### **Important Dates:**

- February 16, 2023: Reception of abstracts through the platform <https://uach.mx/eventos/congresomde/>
- March 1, 2024: Acceptance letters submission.
- March 15, 2024: Submission of full papers by participants.
- April 10, 11, and 12, 2024: Binational Conference.
- January 2025: Publication of accepted articles.

The publication of works is subject to acceptance and scheduling by the publisher.
